

BASIC AND CLINICAL RESEARCH AWARDS 2023 OF THE PHARMAMAR FOUNDATION

INTRODUCTION

PharmaMar Foundation is a non-profit organization whose purposes include contributing to the maintenance and development of scientific research at a national and international level, promoting the development of medicine, improving patient care, training professionals, medical education and health education in general. In order to achieve the aforementioned purposes, the PharmaMar Foundation's Statutes provide that, among other activities, it may award prizes to individuals and/or projects developed in the field of health and/or scientific research.

For this reason, based on its objectives, the PharmaMar Foundation announces the 1st edition of its Annual Basic and Clinical Research Awards for national or foreign researchers who have made a significant contribution to the development of biomedicine and health sciences, either in Spain or abroad, in the areas of oncology, virology or inflammatory diseases, and who maintain a recognized scientific level of activity in any of those areas.

CONVOCATION

PURPOSE OF THE AWARDS

Objective: By creating and awarding the PharmaMar Foundation's Annual Research Awards for Basic and Clinical Research, the aim is to recognize the efforts and merit of researchers who have conducted basic research in the areas of oncology, viral or inflammatory diseases, with a view to obtaining knowledge with a clinical application, at any methodological level (Basic Research Award), or have developed their work in clinical research in oncology, infectious or inflammatory diseases, at any methodological level (Clinical Research Award), making an outstanding contribution to progress in these areas of research and health. The creation of these Research Awards does not recognize a specific research project, but rather the Candidate's entire career and scientific trajectory in the field of oncology, viral or inflammatory diseases.

Field of action: Research in biomedicine and health.

PRESENTATION OF CANDIDATURES

Candidates ("Candidates") for the Basic and Clinical Research Awards may be national or foreign researchers who carry out their research work in the areas of oncology,

infectious or inflammatory diseases in health and/or research centers, public or private, in Spain or abroad.

Candidates for the Awards must be proposed by individuals or institutions in the hospital, biomedical science or health sciences fields, whether Spanish or foreign. Trustees or employees of PharmaMar Foundation, employees of Pharma Mar S.A. or its subsidiaries, and any person who provides services for those companies on an exclusive basis are not eligible for any of the Prizes.

In exceptional situations, the Jury reserves the right to reassign the nomination to the modality (basic or clinical research) when there is reasonable doubt as to the suitability of the choice proposed by the proposer.

No Candidate may be awarded a prize in more than one of the two categories of the PharmaMar Foundation Research Awards.

Proposals should be submitted by sending the following documentation in electronic format and in Spanish or English through the PharmaMar Foundation's website (www.fundacionpharmamar.com):

- i. Application Form
- ii. Letter of support
- iii. Candidate's CV,
- iv. Description of the Candidate's scientific career (the description should be no longer than 800 words in Word format).

The nomination period is expected to be open from June 19, 2023 until October 10, 2023 at 00:00 (inclusive).

The PharmaMar Foundation undertakes to preserve the privacy of all information collected and not to reveal the identity of the participants until the jury issues its verdict.

The submission of nominations implies full acceptance of these rules.

CHARACTERISTICS OF THE PRIZES AND ENDOWMENT

<u>PHARMAMAR FOUNDATION PRIZE FOR BASIC RESEARCH:</u> For researchers carrying out basic research oriented to clinical application in the areas of oncology, viral or inflammatory diseases.

<u>PHARMAMAR FOUNDATION PRIZE FOR CLINICAL RESEARCH:</u> For researchers working in clinical research in the areas of oncology, viral or inflammatory diseases.

In both modalities, the prize consists of a single and total amount of 20,000 euros gross.

In addition, each of the winners will receive a statuette and a diploma accrediting them as the winner of the PharmaMar Foundation Award for Basic or Clinical Research 2023, as appropriate.

The awards are compatible with other subsidies or aid from any public or private administration or entity, whether national, European Union or international organizations.

THE JURY

Each category of the PharmaMar Foundation Research Awards will have its own jury. Each jury responsible for selecting the winners will consist of four members appointed by the PharmaMar Foundation Board of Trustees and will be structured as follows:

(i) A President.

(ii)One Vice-Chairman, to be selected from among the PharmaMar Group's preclinical or clinical research teamTwo members.

A Trustee of the PharmaMar Foundation or its Chief Operating Officer (as determined by the Board of Trustees) will also sit on each jury as a non-voting secretary.

The decision of each jury shall be taken by a simple majority of its members. Their decision is final.

Conflict of interest: Jury members may not endorse Candidates or be Candidates for the Awards. Furthermore, in the event of any conflict of interest in relation to a Candidate, the member of the jury must inform PharmaMar Foundation and may not vote in favor of the candidacy with which there is a conflict of interest.

Personal and non-delegable vote: The vote of the members of the jury must be cast in person at the time of voting, and it shall be non-delegable.

If the Jury so decides, the competition may be declared void in any of its categories.

RESOLUTION AND AWARDING OF PRIZES

Prior to the final decision on the granting of the Awards, the winning Candidate will be informed of the Jury's vote on the decisions adopted by the Jury and of the conditions and terms under which it is proposed to grant each of the Awards, requiring the written acceptance of the said Candidates within a maximum period of 10 days by e-mail to the following address: dfernandez@fundacionpharmamar.com.

Once the Award in question has been accepted by the winning Candidate, he/she will be considered as "Awardee".

Once the Prize in question has been accepted by the winning Candidate, the Jury's decision will be published on the PharmaMar Foundation's website and by any other means that the PharmaMar Foundation deems appropriate.

The prizes will be awarded to the Laureates at a public ceremony organized by PharmaMar Foundation in the last quarter of 2023, the date of which will be announced on the Foundation's web page (www.fundacionpharmamar.com). In order to receive the prize, the prizewinner must attend the awards ceremony.

Attendance at the award ceremony by the Laureates is mandatory.

Upon express acceptance by the prizewinners in each category, who declare that they are aware of, and accept the terms and conditions governing this convocatory for entries, the prize money will be paid within five days following the prize-giving

ceremony, by bank transfer to the bank account designated by the prizewinners. PharmaMar Foundation shall not be liable for any improper use or breach of the duty of good faith by the prizewinners of the Prizes. The Prizewinners shall be responsible for the payment of all applicable taxes, as well as for any other expenses or withholdings associated with or in connection with the presentation, accreditation and use of the Prizes.

Failure to comply with the requirements established in this convocatory could result in the cancellation of the convocatory and the obligation to reimburse the amount received.

INFORMATION USE AND DATA PROTECTION

The PharmaMar Foundation will announce the winning Candidates through the medium it deems most appropriate.

The winners accept and authorize that their data, image and voice may be taken during the Awards Ceremony and may be disseminated in any medium, such as the PharmaMar Foundation's website, social networks, the media or any other medium used by the Foundation to carry out its communication activities. This authorization is granted completely free of charge, with no territorial or time limit. By accepting these terms and conditions, Candidates express their express and unequivocal consent for the data provided to PharmaMar Foundation, including the candidacies submitted, their image, voice, name, among others, to be published on PharmaMar Foundation's websites.

In addition, PharmaMar Foundation reserves the right to publish and disseminate the name and image of the Candidates attending the awards ceremony, by any means and in any format it deems necessary and appropriate, without any obligation to make and/ or pay any compensation whatsoever, without any time or territorial limit.

Candidates and Laureates may in turn disseminate the Prize and use the name, trademark and logo of PharmaMar Foundation for this purpose, provided that they obtain express prior authorization from PharmaMar Foundation. They may not use any logo, trademark or name of PharmaMar Foundation for any purpose other than those detailed herein with the required prior authorization.

The legal provisions applicable to the protection of personal data will be respected in the convocatory for applications. In accordance with current data protection legislation, the PharmaMar Foundation will process the personal data of Candidates and Awardees for the following purposes:

- (i) To allow you to participate in the PharmaMar Foundation Awards and manage your participation in them; to manage the development of the Awards and evaluate your participation in them; to designate the Laureates and make the necessary arrangements for them to be able to enjoy the award.
- (ii) Publish, disseminate and promote the PharmaMar Foundation awards (including for possible future editions), as well as publish, disseminate and promote the Laureates, and their publication in different media, in accordance with the provisions of these terms and conditions.
- (iii) Send you communications related to PharmaMar Foundation awards, as well as respond to any requests, questions or queries you may have.

In the event that the interested party provides data of third parties, he/she declares that he/she has their consent and undertakes to provide them with the information contained in this section.

Participants in the convocatory undertake not to provide personal information of patients or other persons who have not given their consent for this purpose when this is required by law.

The basis for legitimizing the processing of personal data by PharmaMar Foundation to manage participation in the Awards is the fulfillment of the legal relationship established with the Candidates in the terms indicated in these terms and conditions.

PharmaMar Foundation may disclose your personal data to: (ï) service providers with whom we have service contracts that include access to personal data. Where such service providers are located outside the European Economic Area, any transfer of personal data will be carried out in accordance with international data transfer restrictions, including, where appropriate, by signing standard contractual clauses for data processors; (ï) service providers with whom we have contracts for the provision of services that include access to personal data.

(ii) PharmaMar and its subsidiaries; (iii) public authorities, courts and tribunals, in the cases provided for by law.

Candidates' and Awardees' personal data will be kept for as long as we need it to fulfill the purposes for which we have collected it. Once your relationship with The PharmaMar Foundation has ended or when you exercise your right to erasure, opposition or limitation of processing, we may keep some of your personal data for as long as necessary to comply with our legal or regulatory obligations, as well as to meet any liabilities arising from their processing.

Interested parties may exercise their rights of access, rectification, erasure and objection, where applicable, with respect to the processing of their personal data under the terms established by law, by writing to the contact address of PharmaMar Foundation (info@fundacionpharmamar.com), providing proof of their identity. ACCEPTANCE OF THE TERMS AND CONDITIONS

The presentation of the candidatures implies the full acceptance of these rules and the unappealable decision of the Jury, whose interpretation will correspond to the members of the Jury. Any failure to comply with the deadlines or procedures reflected in these rules will deprive the Candidate of the possibility of being eligible for the Awards.

In the event that the PharmaMar Foundation detects that any of the points described in these terms and conditions have not been complied with, the candidacy may be withdrawn.

JURISDICTION

For any controversy that may arise in the interpretation and application of these rules, the Candidates accept the criteria of the Jury of the PharmaMar Foundation regarding the resolution of any issue arising from this competition, and its decision shall be final.

However, and subsidiarily, both the Candidates and PharmaMar Foundation, waiving their own jurisdiction, if any, expressly submit to the jurisdiction of the Courts and

Tribunals of the city of Madrid to resolve any differences that may arise in the interpretation and execution of these rules.

PharmaMar Foundation reserves the right to modify and/or cancel these terms and conditions at any time, without any obligation to compensate third parties, by publishing the modifications on the website www.fundacionpharmamar.es.
